

AGREEMENT
On the USE of PERSONAL DATA

1. For the purposes of this Agreement, the following terms shall have the following meaning:

"Site" - is a site located on the domain name vashtrener.com.ua.

"Site Administration" - the persons authorized to operate the Site.

"Site User" - any person who uses the Site.

2. For the purpose of compiling of the training program, as well as for the other purposes specified below, the Site Administration collects, stores, protects, processes and disseminates information about the Site Users (User Personal Data) in the order specified below.

3. The User Personal Data are stored in the Site Administration's personal database with the right of the Site Administration to use them, until they are withdrawn at the written request of the User.

4. The Site Administration treats the confidential information of any person who has become a User of the Site with respect and responsibility. By accepting this Agreement, the User gives his/her unambiguous and undisputed consent to the processing (including collection and use) of information about the User provided by him/her personally, including when filling out the questionnaire, in accordance with the provisions of the Law of Ukraine "On Protection of Personal Data" and the Policy of the Site Administration On Personal Data Protection. The User gives his/her approval to the Site Administration to collect, use, transmit, process and maintain the information provided by the User in order to provide the relevant services. The User agrees that the Site Administration has the right to provide all personal data of the User to the state bodies according to their requests, and in the absence of such requests, but in cases where the Site Administration is obliged to do so in accordance with the current legislation of Ukraine.

5. The Site Administration is obliged to collect only the personal data that the User voluntarily provides it with: in the case when the data is submitted for the provision (improvement) of the Services to the User.

6. The Site Administration collects basic personal data such as name, surname, address and e-mail address and as well as secondary (technical) data.

7. According to this Agreement, the User Personal Data include:

- Standard data that is automatically received by the http server when accessing the Site (host IP address, requested resource address, time, type and information of the viewer that sent the resource request, type of operating system of the user, the address of the page from which the transition to the requested resource was done etc.);
- Data provided by the Users, including, but not limited to, the following: health, email addresses, names, contact information;
- Other information obtained or generated when accessing the Site through various tools, including the use of cookies: statistics of site views, accounting of the amount of information received and transmitted;
- Information obtained from the use by the Users of their accounts on social networks like facebook.com and others in order to interact with the Site (authorizations, votes, etc.), for example - name, surname, date of birth, email address and photo of the User, etc.

8. The Administration has the right to use third party services to collect information about the Site Users through cookies in order to improve the Site and its services.

9. The Administration uses various tools to protect the User's personal data from unauthorized access or disclosure. However, the Administration does not guarantee and is not responsible for the actions of third parties who have improperly accessed confidential information about the Users, and reserves the right to use and disclose certain information from the personal data of the User in connection with potential or such conflicts and court proceedings, as and when necessary to protect the rights.

10. Access to the User Personal Data have:

- Persons whose rights and responsibilities for access to relevant data are established by the legislation of Ukraine;
- Persons and organizations providing support for the services and services of the Site in the extent necessary to provide such support.

11. Rights of the User as a subject of User Personal Data. The User has the right to:

- Obtain information on the location of the Administration as the owner/manager of his/her personal data;
- Require the Site Administration to clarify his/her personal data;
- Apply remedies provided by law in case of violation of the legislation on protection of personal data.

12. The User agrees that the confidentiality of the data transmitted via the Internet is not guaranteed if access to this data is obtained by third parties outside the area of technical means subject to the Site Administration. The Site Administration is not responsible for damages caused by such access.

13. The Site Administration may use any information collected through the Site for the purpose of improving the content of the Site, its refinement, transmission of information to the User (on request), for marketing or research purposes, as well as for other purposes that are not contrary to the provisions of the current legislation of Ukraine.
